

# Boyle's addition of GMC to Buick called a success

Several months later, Greg Harrell joined the dealership as Collision Repair Center manager. Harrell brings 25 years of body shop experience to the dealership, which he says he joined because Boyle Buick GMC Truck is the kind of family owned and operated local business he prefers. In addition, he was attracted by the lack of turnover among employees.

Boyle says the dealership has no intention of sitting on its laurels. In the spring of 2012, construction will begin on a new showroom. He explains, "With all the advancements at Buick and GMC, we now offer some of the most beautiful and luxurious vehicles available in Harford County. Soon, customers will enjoy a showroom environment that is the equal of these great cars and trucks in every way. And they deserve it."
